ACCEPTABLE INTERNET USE POLICY

Name..... Form.....

Computers play a valuable part in the delivery of the curriculum at Kettering Buccleuch Academy. In order to ensure that students are aware of the conditions for use of both the computer network and the Internet, you are asked to read and sign this document. There are sections for both parents and students to sign. Internet access will not be granted until it is completed and returned.

1. Internet usage

Internet usage is only to support the delivery of the curriculum.

Downloading files from the Internet can only be done with the permission of the class teacher.

Downloading music is forbidden. Key Stage 4 students may be allowed to listen to music (through headphones) at the class teacher's discretion.

Accessing any material of an offensive or illegal nature e.g. pornography, racist material etc. is not allowed and will result in an immediate ban.

Whilst we encourage students to expand their ICT skills, students are not allowed to publish websites they have written via the school network.

2. Network usage

Students are expected to respect the equipment and report any damage to a member of staff immediately.

Accessing another student's area will be considered "hacking" and will result in a ban from using computers.

Students need to report any hardware faults to a member of staff and not try to repair it themselves.
